### OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

This contest (the “**Contest**”) is operated by 4431655 Nova Scotia Limited dba. Sabrosa. (the “**Operator**”), in accordance with these Official Contest Rules (the “**Rules**”).

The Rules are subject to amendment by the Operator at its sole discretion and without notice. By entering the Contest, you agree to abide by the Rules, as they may be amended from time-to-time, and will be deemed to have received and understood the Rules by participating in the Contest.

By entering the Contest, you agree to comply with these Rules and you agree to be bound by the decisions of the Operator. The decisions of the Operator with respect to the Contest are final and binding and not subject to appeal or review. If any provisions of the Rules are held to be invalid or unenforceable, all remaining provisions will remain in full force and effect.

#### **Eligibility and Limitations:**

The Contest is open to legal residents of Nova Scotia, who are 19 years of age or older at the time of entry. It is void outside Nova Scotia and wherever prohibited by law.

Entries are limited to individuals only; commercial enterprises and business entities are not eligible.

Employees of the Operator, their affiliates and advertising agencies, and members of the immediate family of any such persons are not eligible to participate and win. The term “**immediate family**” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether related by blood, as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

The Operator reserves the right to disqualify any individual that it finds, in its sole discretion, to be in violation of these Rules or tampering with the Contest process. Operator reserves the right to refuse an entry from a person whose eligibility is in question or who has been disqualified or is otherwise ineligible to participate. Entries generated by script, macro, robotic, programmed or any other automated means are prohibited and will be disqualified. Any attempt by anyone to deliberately undermine the legitimate operation of this Contest is in violation of criminal and civil laws and the Operator reserves the right to seek damages or other legal remedy to the fullest extent permitted by law.

By entering the Contest, you represent and warrant that you are eligible to participate in the Contest in accordance with these Rules.

#### **Contest Duration**

The Contest starts on February 3, 2026 and ends on April 27, 2026 or such other date as chosen by the Operator (the “**Contest Period**”). All entries must be placed and received during the Contest Period in order to be eligible to win.

## **How to Enter:**

### **1. With Purchase:**

Customers may enter the Contest by spending a minimum of \$20 on a single transaction at a participating Sabrosa location. Each qualifying bill provides one (1) entry. One (1) additional entry can be earned for every Good Robot product purchased by a qualifying customer. One (1) additional entry can be earned for every \$25 in Sabrosa Gift Card purchases purchased by a qualifying customer.

### **2. No Purchase Necessary Method (Mail-In Entry):**

To enter without purchase, participants must write a 500-word essay on why they should win and mail it in its own sealed envelope to:

The Prizes are awarded as-is and no warranties or guarantees are implied or expressed. In order to receive a prize, the selected entrant may be required to provide proof of identification and will have to comply with all the requirements set out in these Rules.

The Prizes are non-transferable, and substitutions or exchanges are not permitted. The Operator reserves the right, in its sole discretion, to substitute and/or modify the prize with a prize(s) of equal or greater value for any reason. ## **Winner Selection and Notification:**

A random drawing from all eligible entries will take place on May 1st, 2026.

Upon being selected, the winner will be notified via email or phone and will have 48 hours after being notified to claim the prize. If the prize is unclaimed within the specified time period, the prize will be forfeited and an alternate winner may be selected by the Operator in its sole discretion.

Before being declared a winner, the winner must correctly answer a mathematical skill-testing question. If the winner provides an incorrect answer, the prize will be forfeited, and an alternate winner may be selected by the Operator in its sole discretion.

The winner agrees to have their photo taken and used by the Operator in its marketing material(s).

## **Limitation on Liability**

By entering the Contest, you release Operator, and its affiliates, subsidiaries, parent companies, related companies, officers, directors, agents, promotional partners and employees (the “Released Parties” from any and all liability whatsoever for any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Contest or with the acceptance, possession, or use of the prize, including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light. By entering the Contest, you also agree to fully indemnify the Released Parties and hold each of them harmless from any and all claims, costs, losses, or damages of any kind arising out of or in connection with the Contest, including any use of the prize, by any third parties.

You also agree that any and all disputes which cannot be resolved between the parties, and any causes of action arising out of or connected with the Contest, shall be resolved individually, without resort to any form of class action. You consent to the exclusive jurisdiction of the courts located in Halifax, Nova Scotia, and agree that all matters pertaining to these Rules and disputes arising hereunder shall be governed by and interpreted in accordance with the laws of the Province of Nova Scotia and the laws of Canada applicable therein, without regard to any conflicts or choice of law rules or provisions (whether of Canada or any other jurisdiction).

Under no circumstances will you be permitted to obtain awards for, and you hereby waive all rights to claim, punitive, incidental or consequential damages, including attorneys' fees, other than your actual out-of-pocket expenses (i.e., your costs associated with entering the Contest), and you further waive all rights to have damages multiplied or increased.
