

# **SABROSA TRIP FOR 2 TO MEXICO**

## **CONTEST TERMS & CONDITIONS**

### **Introduction**

By participating in the contest, you are agreeing to these contest terms and conditions. The contest is being run by Sabrosa, 4431655 Nova Scotia Limited.

### **Eligibility to Enter**

The contest will run from February 1<sup>st</sup>, 2024, to March 31<sup>st</sup>, 2024 and all valid entries must be received by the end of day March 31, 2024.

The contest is open to entrants who are at least nineteen (19) years of age or older and residents of Nova Scotia. Sabrosa associates, employees, and same household family members of said employees and associates are excluded from the draw. Proof of age and residency will be required.

By entering the contest, you confirm that you are eligible to do so according to the contest terms and conditions and you are eligible to receive any prizes that may be awarded to you.

There is a limit of one entry per person, per day (except with the purchase of a Good Robot beverage as outlined in “How to Enter” and the competition is completely free to participate. No purchase necessary ballots can be obtained in person at Sabrosa, 153 Hector Gate, Dartmouth, Nova Scotia. Take Out orders and Delivery orders are not eligible to participate in the contest.

Odds of winning depend on the total number of valid entries received during the contest.

### **How to Enter**

There are three ways to enter the contest:

- 1) Dine in customers will receive a QR code at the bottom of their receipt. Upon scanning the QR code they will be taken to a digital ballot where they will need to submit specific information to be entered in the contest.
- 2) Dine in customers who purchase a Good Robot beverage will be given a paper ballot in addition to the QR code as a secondary entry.
- 3) No purchase necessary ballots can be obtained in person at Sabrosa, 153 Hector Gate, Dartmouth, Nova Scotia.

## **The Prize**

Participants acknowledge that participating in the contest is only a chance to win the prize and that they have not actually won a prize without being informed by Sabrosa that they are the winner of the said prize.
